1. Non-Blacklisting

That the above-mentioned institute is **not blacklisted, debarred, suspended, or otherwise declared ineligible** by any Government department, public-sector organization, private institution, regulatory authority, examination/awarding body, or other competent authority, to the best of my knowledge and belief.

2. Truthfulness of Information

That all information, documents, certificates and declarations submitted by the institute to the **Global Board of Technical & Professional Education (GBTPE)** in connection with registration, affiliation, examination, assessment or any other Board process are true, correct, complete and genuine.

3. No Own Certificates

That, where applicable, the institute shall comply with the relevant rules, regulations, standards, curricula, competency requirements, assessment requirements and other applicable requirements of **NAVTCC/GBTPE** and any other competent regulatory or awarding authority applicable to the institute, its courses or qualifications.

6. Admissions and Approved Courses

That the institute shall offer and conduct only those courses/trades for which it has received valid approval/affiliation from the competent authority and/or GBTPE, as applicable.

The institute shall not conduct examinations or claim Board certification for any course that has not been duly approved.

7. Examination and Assessment

That the institute shall cooperate fully with the Board in the conduct of examinations, practical assessments, inspections, verification, monitoring and quality-assurance activities and shall comply with the instructions of authorized Board officials and approved assessors.

8. False Information or Misrepresentation

That if any information, document or declaration submitted by the institute is subsequently found to be false, misleading, forged or materially incorrect, the Board shall have the right to take appropriate action under its applicable rules, including suspension or cancellation of affiliation/approval and any other action available under applicable law or regulations.

9. Change in Status

That the institute shall promptly inform GBTPE in writing if, after submission of this affidavit, it becomes subject to any suspension, blacklisting, debarment, legal restriction or other material change that may affect its eligibility to remain affiliated with or approved by the Board.

10. Binding Undertaking
